The FSRU shall supply regasified LNG for the power plants located in Kerawalapitiya and Colombo area.

The Pipe Line End Manifold (PLEM), subsea pipeline and onshore pipeline up to the boundaries of the power plants will be established by Ceylon Petroleum Corporation on BOOT basis.

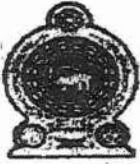
